4. How will the staff training and the data entry necessary for the new computer system be funded?

The offices of the seven Orleans Parish assessors and the office of the Board of Assessors appear to have a combined budget of over \$4.5 million, a lot of money. The IQ Ticket promises substantially to reduce the overhead of the offices by eliminating the salaries and benefits to seven assessors; the IQ Ticket promises to work without compensation. All resulting savings will be directed to making the new computer system operate effectively and to completing the State Tax Commission mandated parish-wide reassessment.
